- 2) Cleared the canopy/lines of twists and tangles.
- 3) Performed a line sequence check and condition of lines.
- 4) Knows how to perform all the packing checks at the appropriate stages.
- 5) Can competently pack a parachute ready for jumping.
- 6) Has been Instructed on how to inspect the assembly for damage and deterioration.
- 7) Can competently change the main closing loop
- 8) Instructed in container/canopy compatibility.
- 9) Achieved the requirements laid down in the British Skydiving Operations Manual. (and has been instructed on Sections 6 & 14 specifically)

\*Certification for main parachutes and assemblies may only be carried out by **at least** a CSI or AFFI (who also holds the same packing qualification on their own Packing Certificate), or a Parachute Rigger.

- N.B. (1) Sets of British Skydiving Safety Notices and Safety Information Bulletins are available from British Skydiving HQ or may be downloaded from the British Skydiving website: <u>www.britishskydiving.org</u> These should be readily available to all CI's and Riggers. All packing and rigging related documents are listed in Form 238.
  - (2) Once the conditions have been complied with and the specific types of parachutes and assemblies have been recorded overleaf. The form must be sent to British Skydiving HQ for recording and endorsement. Once it has been returned subsequent endorsements to this certificate for additional types are not required to be referred to British Skydiving.
  - (3) Approved Packing Certificates will only be issued to Full British Skydiving members.
