### DISPLAYS THAT TAKE PLACE IN A CONTROLLED ZONE (CTR)

All applications relating to displays within CTRs should be sent (as well as to the British Skydiving and Airspace Regulation Ops (AROps)) direct to the relevant airfield (see addresses below) Air Traffic Services Unit (ATSU), with the exception of Heathrow, Gatwick, London City, Luton, Southampton and Stansted (for which NATS Swanwick is responsible – See Form 185)

Send applications (Form 185) addressed to the ATC Ops at the airport concerned. If you need to telephone, you should ask for 'Air Traffic Control'. When faxing. Put 'For the attention of ATC Ops'. If urgent, put 'For the attention of ATC Supervisor'.
