TI PROBATIONARY REQUIREMENTS

After completing the TI Course, newly qualified Tandem Instructors must adhere to the following limitations:

- a. Minimum exit altitude 9000ft AGL.
- b. No Formation Skydiving (FS) will take place
- c. The Tandem Student must be of similar stature to the TI.
- d. No Tandem Students over 55 years of age.
- e. No Tandem Students with mobility or disability needs.
- f. An experienced camera flyer may accompany the Tandem instructor if cleared to do so by the CI.
- g. The Tandem Instructor must log the 20 jumps in their personal and on the probationary record, which must be signed and witnessed by at least a Tandem Instructor.
- h. A minimum of five landings must be filmed for debriefing purposes.
- i. Suspended harness drills should be completed more frequently than the required one calendar month.
- j. Receive a familiarisation brief for the type of aircraft to be used and briefed on any local SOPs relevant to Tandem Skydiving.
- l. Must be made aware of any differences should they jump main canopies that they have not jumped throughout their Tandem Course.
- m. Adequate time between jumps
- n. No more than 5 Tandems jumps per day.

N.B.(1) Any B Licence descents must be conducted as per British Skydiving Operations Manual Section 4, Para 5, Sub Para 5.8

Further limitations to considered during Probationary period

1. During Period A the winds should be limited to 5-15kts on the ground and no significant upper winds (i.e. <30kts at 5000ft)
2. During Period B the winds can be 0-20kts and not significant upper winds (i.e. <30kts at 5000ft)
