**SECTION 4      MINIMUM QUALIFICATIONS FOR FAI INTERNATIONAL PARACHUTIST  
 CERTIFICATE OF PROFICIENCY**

'A' CERTIFICATE (PARACHUTIST): 25 Freefall jumps. 5 Minutes of Freefall time. 5 formation (FS) jumps or, 5 freefly (FF) jumps, involving at least 2 participants and made under the supervision of an instructor. Demonstration of control of the body in freefall in all axes (backloops, turns, barrel rolls etc.). Ability to pack a main parachute.

'B' CERTIFICATE (FREEFALL PARACHUTIST): 50 Freefall jumps. 30 Minutes of Freefall time. Successful completion of 10 formation (FS) skydives, at least 5 of which must involve a minimum of 3 participants or, ten formation freefly (FF) jumps, at least five of which must involve a minimum of three participants.

'C' CERTIFICATE (EXPERIENCED PARACHUTIST): 200 Freefall jumps. 1 hour of freefall time. Successful completion of 50 formation (FS) skydives, at least ten of which must involve a minimum of 4 participants or, 50 formation freefly (FF) jumps, at least 10 of which must involve a minimum of 4 participants.

'D' CERTIFICATE (SENIOR PARACHUTIST): 500 Freefall jumps. 3 hours of Freefall time.
