OUR HISTORY

The British Parachute Association Ltd., trading as British Skydiving, was formed in 1961 and incorporated as a not-for-profit company limited by guarantee in 1966.

British Skydiving is the governing body of skydiving in the United Kingdom and is committed to maintaining the highest standards of safety in the sport. Careful analyses of accidents and injuries over time has enabled British Skydiving to build up detailed knowledge of the risks in the sport. As risks are identified and assessed, measures to manage and control the risks are implemented. These control measures are set out in our Operations Manual.

High quality training packages delivered by British Skydiving ensures consistency for all delegates starting on the pathway to become an instructor. These courses are run by the British Skydiving Safety and Training Team, in partnership with affiliated Parachute Training Organisations.

British Skydiving co-ordinates a varied programme of competitions, promoting skills development and excellence in skydiving, funding national teams and individuals who meet strict performance standards to World Championships.

It also supports major events such as the British Skydiving National Championships in all the major skydiving disciplines, together with British Skydiving UK Skydiving League (UKSL) and British Skydiving Grand Prix Competitions held at Affiliated Parachute Training Organisations throughout the UK.


We will ensure that our knowledge and development as a body is always of the highest level so that we can support our members to the full.

JOB DESCRIPTION BRITISH



Role Title	Independent Non-Executive Director (Council Member)
Salary	Voluntary – expenses only
Contract	Fixed-term, initially for 3 years

Role Purpose

Our 12-strong Council (Board of Directors) meets immediately following the AGM in January and then six times per year. It comprises ten Elected Non-Executive Directors (NEDs) nominated from, and elected by, the membership, together with two Independent Non-Executive Directors (INEDs).

There is a vacancy in one of the independent seats. All INEDs are selected by the Nominations Committee for ratification at our AGM. It is envisaged that the successful candidate will be co-opted to Council as a non-voting member with a view to formal appointment as a voting member by the AGM on Saturday 27 January 2024.

We seek individuals with strong leadership skills who can continue to develop and maintain British Skydiving's strategic focus and help the organisation to achieve its goals.

Applicants need to be able to make a commitment to British Skydiving and devote the necessary time, have strategic vision, independent judgement, and an ability to think critically and creatively.

Dimensions

Location:	Home-based with 3 in-person Board meetings per year and meetings with staff.
Time Commitment:	Approx. 8 hours per month, plus an additional 2 hours for any Committees.



Specialist Skills

We are looking for candidates who will have an empathy with our sport and our skydiving community, together with skills in one or more of the following areas:

- Legal
- Finance

Additional Skills

The successful candidate will also need be able to demonstrate:

- A track record of success in the private, public or voluntary sector;
- the ability to operate at Board level in a national organisation and to help grow the public profile of British Skydiving;
- the ability to think critically, creatively and strategically; the skills to constructively challenge current thinking at Board level;
- a clear commitment to improving diversity and equality and understanding the needs of under-represented groups in sport;
- a good understanding of the sporting landscape.
